**Background:**

The history of the submission of this application is as follows. The Final EIAR was submitted to the Department of Agriculture and Environmental Affairs (DAEA) (then the Department of Agriculture, Environmental Affairs and Rural Development), on 12 March 2012. A letter of rejection dated 01 June 2012 was issued by the DAEA. An addendum addressing the specifics of this letter was submitted on 24 January 2013 (Addendum 1).
