Appeal against the Sand Draai project is being raised due to the following reasons:

1. The state's access roads are in appalling conditions due to the high volume of traffic on the roads by developers and contractor's. This matter must be addressed before any site development/ construction is undertaken.
2. The availability of water from the river is in question and therefore it cannot be allowed that water be obtained for construction or operational purposes. Mr Kruger also recommended that the SADC and ASSOCOM agreements be looked at including the required EIA and not just the BA reports.
3. All I&APs indicated that the dust generated from the gravel road between the N8 & N14 is a source of major concern. They also indicated that the amount of dust being generated by the road is affecting their produce and livestock which in return affects their income.
4. He further stated that all agreements and solutions being decided on to mitigate or prevent

any further impacts must be set prerequisites to ensure that they are being followed. All solutions must also be completed before any reports are submitted to the Department of Environmental Affairs for consideration by all prospective developer.
