The translation is as follows.

Hi Kim

We were out of the office until now and we are only getting a chance/ the time to respond now. I hope it will still be considered.

The traffic on the road (the gravel road between the N8 and N14 leading to Bokpoort and future developments) that was used during the construction of the current project (Bokpoort), has affected and changed the road considerably. A tar road will certainly have to be built if any following projects will be launched. There are producers/farmers who make use of the affected gravel road to get their products to markets, the status of the road leads to major damage due to bruising of fruits, etc.

There is also a tremendous amount of dust (due to the high amount of vehicles using the road) that descend/ settle on crops and products. The large amount of dust also increases the chances of vehicle accidents due to vision impairment. Tarring of the identified road will resolve all these problems.
