Good afternoon Susanna

Thank you for your comments. I will immediately act on it in our report. Our social specialist will also consider your comments and incorporate in her report. I will also include/add you on our database. You will be notified of any future meetings in regards to the impact study.

Attached is the Afrikaans version of the Background Information Document (BID) that was put together to explain what the projects are about. I hope this helps and you find it sufficient.

Regarding your questions about when the construction of the projects will take place and how you should apply. Currently we unable to provide you with answers. Royal HaskoningDHV is currently working on the Environmental Impact Study. During this process, we aim to identify any / all environmental and social impacts. We try to provide solutions that will help to avoid any future impacts and problems. A final environmental report is then given to the Department of Environmental Affairs (we aim for March 16, 2016). They will then give approval for the project to be built. Only then will we be notified of any jobs. But I believe that the Municipality will be kept informed of any planned construction.
