**REVIEW OF TRAFFIC IMPACT STATEMENT PREPARED BY RHDHV FOR THE PROPOSED
SWWTW UPGRADE, MEREWENT**

This letter is in response to the letter received from DMA on 31st March 2015 (reference P1064). See attached.

1. Information received from the project team indicate that with the expansion at the Southern Wastewater Treatment Facility, is not expected to require additional staff to operate the facility. The improvement will only necessitate additional number of tankers entering and leaving the facility, which was taken into account during the trip generation. Refer to Page 12.
2. With the expansion of the facility and the transportation of the dry sludge from the facility to an external site (still to be investigated), an additional 5 tankers will be required for this cater for this process. The trip generation, distribution and analyses have been adjusted to allow for this. Refer to Page 12.
